DECREE OF THE GOVERNOR OF WEST JAVA NUMBER 561.7/Kep.798-Kesra/2024 CONCERNING

MINIMUM WAGES OF REGENCIES/CITIES WITHIN THE PROVINCE OF WEST JAVA FOR THE YEAR 2025

GOVERNOR OF WEST JAVA,

Considering

- a. that based on Article 88C of Law Number 13 of 2003 concerning Manpower, as amended by Law Number 6 of 2023 concerning the Enactment of Government Regulation in Lieu of Law Number 2 of 2022 concerning Job Creation into Law in conjunction with Article 4 paragraph (1) of the Regulation of the Minister of Manpower of the Republic of Indonesia Number 16 of 2024 concerning the Determination of the Minimum Wages for the Year 2025, the Governor is authorized to establish minimum wages for regencies/cities;
- b. that to determine the minimum wages of regencies/cities for the year 2025, the provisions of the Minister of Manpower Regulation Number 16 of 2024 concerning the Determination of Minimum Wages for the Year 2025 must be adhered to;
- c. that based on the considerations referred to in points a and b, it is necessary to stipulate a Governor's Decree concerning the Minimum Wages of Regencies/Cities within the Province of West Java for the Year 2025;

Observing

 - 2. Recommendations from 27 Regional Wage Councils of Regencies/Cities in West Java regarding the Determination of Minimum Wages for Regencies/Cities for the Year 2025;

HAS DECIDED:

To Stipulate

: DECREE OF THE GOVERNOR CONCERNING MINIMUM WAGES OF REGENCIES/CITIES WITHIN THE PROVINCE OF WEST JAVA FOR THE YEAR 2025

FIRST

: The amount of the Minimum Wages for Regencies/Cities within the Province of West Java for the Year 2025 is as follows:

SECOND

: The Minimum Wages of Regencies/Cities as referred to in the FIRST Dictum shall be payable starting January 1, 2025.

THIRD

The Minimum Wages of Regencies/Cities as referred to in the FIRST Dictum shall only apply to workers with a tenure of less than one (1) year.

FOURTH

: Workers/Laborers with a tenure of less than one (1) year as referred to in the THIRD Dictum, who meet specific qualifications required for certain positions, may be paid wages higher than the minimum wage.

FIFTH

: Employers shall establish and enforce a wage structure and scale in determining the wage amounts to be paid to workers with a tenure of more than one (1) year.

SIXTH

: Employers are prohibited from paying wages lower than the Minimum Wages of Regencies/Cities as referred to in the FIRST Dictum, except for micro and small businesses as agreed upon between the employer and the workers/laborers within the company.

SEVENTH

Employers who have paid wages higher than the stipulated Minimum Wages of Regencies/Cities as referred to in the FIRST

Dictum are prohibited from reducing and/or lowering the wages of their workers in accordance with the provisions of prevailing laws and regulations.

EIGHTH

: This Governor's Decree shall come into effect as of the date of its stipulation.
